8th RACE. (CX4) ALLOWANCE 1 Mile FOR FILLIES AND MARES THREE YEARS OLD AND UPWARD WHICH HAVE NEVER WON A RACE OTHER THAN MAIDEN, CLAIMING, WAIVER CLAIMING, STARTER OR MD SIRE OR MD BRED RACES OR WHICH HAVE NEVER WON TWO RACES.
